JUNIOR PARKING PERMIT APPLICATION**

Any Frank W. The student must present a valid driver's license and vehicle registration when purchasing the decal. Students who currently have a **monetary obligation** to Cox High School cannot purchase a decal until they are free and clear of their debt.

### Rules Regarding Student's Driving, Parking and Use of Parking Lots

1. All automobiles parked on the school grounds must be registered with the school and must display a valid decal inside the front window in the lower corner, driver's side. Parking decals must be properly displayed at all times.
2. **Decals are valid only for the car registered and only for the student to who it was issued. You cannot give, sell or in any way transfer your decal or driving privilege to another student. (30 Day Parking Suspended)**
3. **Decals must be permanently attached.** Decals may not be taped to the windows. Replacement decals are available at no cost for acceptable reasons (i.e. vehicle was wrecked, sold, traded, etc.), however, you must return the original decal either whole or in pieces. There is a **\$45** replacement fee if you do not turn in your original decal.
4. **Any decal found attached to a vehicle for which it was not issued will be revoked.**
5. Student parking is strictly limited to their assigned student parking areas. Faculty, staff and visitor parking are marked accordingly and are off limits to students.
6. Student must be licensed and covered by insurance. The school is not responsible for the automobile or its contents.
7. There is to be no loitering or visitation in the parking lot without permission.
8. Smoking regulations apply to the parking lot as they do to the entire school premises... "NO SMOKING"!!!
9. There will be NO speeding or any form of "WRECKLESS" driving on the school grounds. STUDENTS ARE NOT ALLOWED TO DRIVE OVER THE MEDIAN OR GRASS TO EXPEDITE EXIT/ENTRY TO SCHOOL. (30 Day Parking Decal Suspended)

#### Maximum speed is 5 miles per hour

10. Student vehicles may be subject to search if there are reasonable grounds to believe that drugs, alcohol, stolen property, or other contraband might be present in that vehicle.
11. Parking regulations are strictly enforced. It is considered a privilege to park on the school grounds. Suspension of driving privilege, Wednesday detention, towing of vehicle, and/or suspension from school may occur as a result of any violation of these regulations.
12. **Tire locks are used to immobilize vehicles violating parking rules. Once applied, there is a \$25 fee for its removal. Any damage to the tire lock results in a \$80 fee.**
13. "ABSENCE or TARDINESS" due to vehicle accidents or breakdowns is considered UNEXCUSEABLE.
14. Parking decals are suspended for one semester (eighteen weeks) if a student accumulates seven or more unexcused tardies during a semester. Upon a student's second referral for attendance related issues (i.e. truancy, skipping class, leaving school grounds without permission, etc.) parking privileges will be suspended nine weeks. A third referral for these issues will result in loss of parking privileges for the remainder of their school year.

Applications containing false information will result in denial of parking for the year. Understand that being issued a parking decal provides you with permission to park the registered vehicle if space is available and **that you are not guaranteed a parking space.**
